 2. Distances between signs NOT to scale for purpose of clarity.
 3. All sign placement subject to available safe working space.
 4. The purpose of the Traffic Management Plan is for it to be used only as a guide and all traffic management equipment should be put out according to the 'Safety at Street Works and Road Works - Code of Practice', i.e. Red Book & the 'Traffic Signs Manual Chapter 8', i.e. Yellow Book.
 5. Signs must be placed in accordance with TSM and the scheme RAMS pack.
 6. Site conditions may have changed since the design of the drawing; any changes which subsequently affect the design need to be reported by the Traffic Management Operative & any changes implemented must comply with Chapter 8.
